

## Course Description I

<b>Title</b>	Cutting and Tailoring a Bespoke Jacket Practices and Processes
<b>Accreditation(s)</b>	The provider is accredited by awarding organisation Skills and Education Group (SEG) Awards to deliver Level 3 & 5 qualifications (RQF) and apprenticeship (NVQ) training in Bespoke Tailoring.  The Tailoring Academy is accredited by the British Accreditation Council (BAC) for Independent Further and Higher Education as a Short Course Provider.
<b>Approval(s)</b>	The course is approved by the UK Fashion and Textile Association (UKFT). It is one of two courses comprising a programme for international students wishing to study Bespoke Tailoring at the highest level in the UK. The programme is the only non-regulated training provision approved by the Sector Skills Body.
<b>Course Purpose</b>	The course is focused on practical skills and industry-relevant knowledge delivery at the highest level, to fill skills gaps in the UK and international markets.  The course also supports employability with skills and knowledge delivery in areas like quality management and communication. Graduate bespoke cutter and tailors can apply for work in the UK under the Skilled Worker visa scheme.  Information on UK Employment Rights and Responsibilities (ERR) is made available to graduates upon request.

<b>Course Duration</b>	<p>18 weeks (September to February)</p> <p>432 guided learning hours (GLH)</p> <p>540 total course hours (TCH)</p>
<b>Mode of Delivery</b>	<p>The course is delivered full-time and in person, at state-of-the-art workshop premises in Macclesfield, Cheshire / UK.</p> <p>Delivery is largely in practicals, with some elements in seminars.</p> <p>Remote delivery is available to participants via live video online class only when extenuating circumstances require it.</p>
