


Case Study I




### **Starting a Tailoring Business**



#### LIVING IN THE UK

#### When should I start looking for a flat/room?

As soon as you have signed your course agreement, but you may find that accommodation is becoming available even on a short notice basis.

How difficult is finding accommodation in the UK as an outsider?

We provide access to newly renovated, shared accommodation upon request.

Do you need any other insurances / would you recommend getting any?

There aren't any legal requirements for further insurances, but you may want to consider travel insurance etc.

## VISA / IMMIGRATION

#### Can I study both courses on a visitor visa?

Yes. Each of our courses is under six months long. You need a second visa to enrol for the second course.

#### If one has to leave between courses, for how long?

Please see page 20 for a statement from UKVI (Visas and Immigration).

#### I'm a non-visa national, but is it recommended I apply for one anyway?

Applying for a Standard Visitor visa prior to travel is not recommended for nationals of non-visa countries. They can use the eGates (biometric passport) at the UK border.

#### I'm a visa country national, do I need to apply for my visa prior to travel?

Yes, please see page 20 for more information.

#### Does the TA issue a formal letter of acceptance, to show border officials?

Yes, we will issue a formal letter under the BAC accreditation scheme as part of the documentation required for entry to the UK.

#### THE ACADEMY

### Is the TA open during the holidays/breaks?

For insurance reasons, this is subject to the availability of staff. Likely to be the case except for Christmas and Easter bank holidays. The workshop is open to students every Friday.

#### What is the estimated cost of materials?

All materials and trimmings are included in the course fee.

What do employment opportunities look like? Are positions offered close to/just after completion of the course?

Under the Standard Visitor visa, students are not permitted to work in the UK. You can apply for a work visa from outside the UK.

#### THE PROGRAMME

What is the ratio of practical lessons to theoretical ones?

90%/10%

Is there homework?

What does the majority of students do after finishing the course?

## **British Accreditation Council (BAC) <-> UK Visas & Immigration (UKVI)**

Q: If a student had studied a six-month course with an institution, can they then apply for a second Visitor Visa to study another course at the same institution within the same year?

A: Effectively yes, the student would need to be able to demonstrate that they have been offered a place on a course of study and that they aren't continuing a course in excess of 6 months via frequent and successive study.

Q: What is the minimum time allowed between applying for a second Standard Visitor Visa and do students need to leave the country in order to make the application?

A: There is no specific time limit or requirement for a student to be outside the UK for a specific period between periods of study on the Visitor route, the requirement is simply that a student must not be using the Visitor route to undertake 'Frequent and Successive' visits or undertake a longer course that should be undertaken on the Student route.

In effect, this means that a student could be granted on the Visitor route to study, then apply again shortly after for a second course, this would be acceptable, provided the student has been offered a place on a course and can demonstrate that they aren't undertaking a course longer than six months via multiple visits or essentially living in the UK under the Visitor route.

Visit visas cannot be applied for from within the UK, a Visitor would either have to apply prior to travel if they are a visa national or apply on arrival at the UK border if they are a non-visa national.

### Visitors from outside the European Economic Area (EEA):

- If you are visiting England from outside the EEA, you'll be charged for NHS secondary care at 150% of the standard NHS rate.
- Make sure you are covered for healthcare through personal medical or travel insurance for all your visit.

## Healthcare

The National Health Service (NHS)



### **Visitors from inside the EEA** (including the EU)

- If you are a visitor from an EU country and you fall ill or have a medical emergency during your temporary stay in England, you can use your European Health Insurance Card (EHIC).
- Your EHIC will cover you for treatment that becomes medically necessary during a visit to England, until you return to your country.
- Consider private health insurance in addition for a more comprehensive cover.
